4. FIRST-AID MEASURES

- In case of eye contact : Flush eye with copious quantities of water.
Remove contact lenses, if present and easy to do. Continue rinsing.
If persistent irritation occurs, obtain medical attention.
- In case of skin contact : Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available.

- High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function.

5. FIRE-FIGHTING MEASURES

Suitable and unsuitable extinguishing media

Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material. Glove thickness should be typically greater than 0.35 mm
