If persistent irritation occurs, obtain medical attention.

### 4.2 Most important symptoms and effects, both acute and delayed

Defatting dermatitis signs and symptoms may include a burning sensation and/or a dried/cracked appearance.

### 4.3 Indication of any immediate medical attention and special treatment needed

Treatment : Potential for chemical pneumonitis.

High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function.
