SECTION 4. FIRST-AID MEASURES

Protection of first-aiders	: Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. : When administering first aid, ensure that you are wearing the appropriate personal protective equipment according to the incident, injury and surroundings.

Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material. Glove thickness should be typically greater than 0.35 mm depending on the glove make and model.
